#### ADMINISTRATIVE HISTORY

The Montgomery County Historical Review Committee was established by the County Council on June 12, 1973 to ensure the successful completion of the History Project. This project was initiated in conjunction with the Montgomery County Historical Society upon the approach of the bicentennial celebrating the founding of the County on September 6, 1776. Its goals were to produce a comprehensive written history of the County and to locate, inventory, and reproduce its basic historical records. Responsibility for devising a preliminary work plan, scope, and general procedures was delegated to the Department of Public Libraries. County funds were allocated to locate, inventory, and reproduce local records, in addition to an oral history project initiated by the League of Women Voters of Montgomery County. One component of the project, the history *A Grateful Remembrance: The Story of Montgomery County, Maryland* by Richard K. MacMaster and Ray Eldon Hiebert was published in 1976 by the Montgomery County Historical Society and Montgomery County Government.

#### SCOPE AND CONTENT NOTE

The records of the Historical Review Committee comprise materials from 1973 to 1976 and consist of memoranda, correspondence, resumes, reports, press releases, clippings, resolutions, agendas, contracts, notes, outlines, and photographs. Some of these appear to be personal files maintained by Dr. Richard K. MacMaster and include historical essays, items relating to a Conference on Pacifism which he helped to organize in 1974, and records relating to the Bicentennial Consortium for Local History, of which he was chairman of the executive committee. Of special significance among the research notes and outlines are those relating to the history of the County's African-American population. The correspondence folders document research methods, the compilation of sources, and access and preservation projects undertaken during the project. There is also a collection of publishing materials, including the photographs cropped for inclusion in the final book, as well as other historical material collected for the History Project.

#### SERIES DESCRIPTIONS

Series I: Administration, 1973-1975 (0.15 cubic feet)

This series contains proposals, contracts, resumes, project plans, and budgetary documents related to the general administration of the History Project, by the Historical Review Committee. Correspondence to and from committee members is located in Series II. Material is arranged chronologically.

# Series II: Correspondence, 1972-1975 (0.15 cubic feet)

This series contains correspondence from HRC members, Richard MacMaster (in the course of his research), genealogical inquiries related to the project, and communication with local civic

associations. Material is arranged by topic.

# Series III: Book Research, 1973-1976 (0.3 cubic feet)

This series contains reference material, notes, research on specific topics, editing/criticism of drafts, as well press releases/news coverage of the History Project and follow up material after project completion. Also included is material on a Conference on Pacifism that MacMaster organized during his time working on the project. Material is arranged by topic.

## Series IV: Publication Material (1 folder)

This series contains photographs, negatives and proofs, consisting of the photographic material used in <u>A Grateful Remembrance</u>. Some photos have evidence of crop markings and tape damage from the publishing process in 1976. Also included are facsimiles of historic documents used in connection with the History Project. This material is located in Flat File 16.
