#### **ADMINISTRATIVE HISTORY**

Founded in 1937, the purpose and aims of the Montgomery County Branch of the National Association for the Advancement of Colored People are: to improve the political, educational, social, and economic status of minority groups; to eliminate racial prejudice; to keep the public aware of the adverse effects of racial discrimination; and to take lawful action to secure its elimination; consistent with the efforts of the national organization and in conformity with the Articles of Incorporation of the Association, its Constitution and Bylaws and as directed by the National Board of Directors.

## **EXTENT**

0.15 cubic feet: 1 (shared) letter-size Hollinger box.

#### SCOPE AND CONTENT

The records of the Montgomery County Branch of the National Association for the Advancement of Colored People (NAACP) consist of five folders and one videotape, mostly of printed material from 1987-1988. Material includes programs, reports and newsletters. Also included is material from 1958-1959 relating to a request for an ordinance to prevent discrimination by Montgomery County businesses.

The collection of printed material was located already processed but without a finding aid. Paper material from 1958-1959 and video interviews from 1989 were donated in 1999 (Accession 99-24).

#### PROCESSING PROCEDURES

General processing procedures consisted of discarding duplicates, unnecessary binders, and routine transmittals. Oversized documents were removed from the original location in their assigned series and placed in separate containers. Separation sheets were inserted in the original location within the folder to indicate the new location of any records placed elsewhere. Preservation copying of newspaper clippings was performed whenever feasible.
